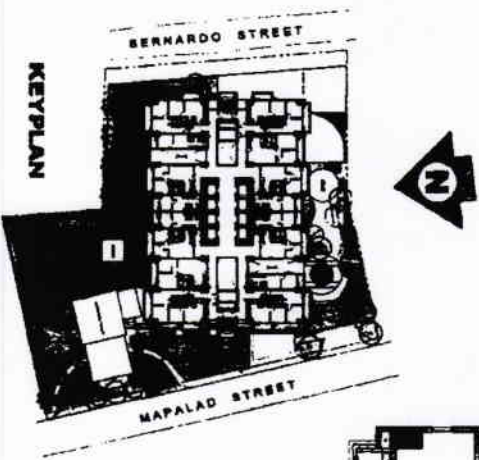
CAMERON RESIDENCES 3RD FLOOR PLAN
